**Notice of Update on AEON CARD WAKUWAKU Reward Program**

Thank you for your continued support of AEON Card! Please be informed that AEON CARD WAKUWAKU Reward Program will be updated. The below changes will start to apply to card transactions to be shown in the statements issued in July 2024 ("Relevant Date").

**1. Reward Offering Mechanism**

Starting from the Relevant Date, Eligible Customer shall be offered of WAKU COIN (\$1 WAKU COIN = HK\$1 cash rebate; redemption is subject to the option(s) available) instead of cash rebate for Eligible Transactions and will be posted in the relevant Credit Card monthly statement.
