UNICEF Young Envoys Programme 2022 Appointment Ceremony

Hong Kong Committee for UNICEF (UNICEF HK) hosted UNICEF Young Envoys 2022 Appointment Ceremony on 25 August. Mr. Daisuke Takenaka, Executive Director, AEON Credit Service (Asia) Co., Ltd. and Mr. Ivan Chu, Chairman of Advocacy Committee, UNICEF HK presented Certificate of Appointment to Young Envoys who have completed the programme. They also encouraged our youth to gain a deeper understanding of crises faced by children around the world, understanding the developmental needs of children as they grow, and bring positive changes to survival and growth of every child.

UNICEF HK has organized 26 training sessions to the aspiring youth who have passed a rigorous selection process. The experience offered them continuous learning, self-improvement and community service opportunities. Almost 1,400 Young Envoys were nurtured since UNICEF HK launched the Programme in 1996.

Michelle Ngai said it has helped to strengthen her analytical skills and equipped her to be an active global citizen. Chloe Tang described becoming a Young Envoy helped her realize she can make positive changes to the community and local children. She will keep on upholding the missions of Young Envoys and contribute to children’s rights promotion.

Application period for next year’s Young Envoys Programme will commence in October. Full-time students aged 12-18 who are interested to become a children’s rights advocacy leader are
