

## <u>Terms and Conditions of AEON Too Easy Tax Loan New Customer Early Bird Promotion - Extra HK\$200 Cash Rebate</u> Offer ("EB Promotion"):

- 1. EB Promotion is valid from 24<sup>th</sup> September, 2025 to 23<sup>rd</sup> October, 2025 (both dates inclusive) ("EB Promotion Period").
- 2. New customers who have successfully applied for AEON Too Easy Tax Loan ("Tax Loan") during EB Promotion Period: from 24<sup>th</sup> September, 2025 to 23<sup>rd</sup> October, 2025 and with loan confirmation on or before 23<sup>rd</sup> October, 2025 ("EB Loan Confirmation Period"); and satisfy the requirements as specified in the paragraph 4, 5, 6 & 7 under the Terms and Conditions of 'AEON Too Easy Tax Loan Cash Rebate Offer', are entitled to extra HK\$200 cash rebate ("Extra Cash Rebate").
