1. AEON CARD WAKUWAKU 獎賞計算方法

由有關日期起，合資格客戶憑信用卡合資格簽賬所獲之 WAKU COIN 獎賞比率及每月回贈上限將有以下更改：

於每個月結單周期，每名合資格客戶可享無上限「基本獎賞」及最多\$200 WAKU COIN 之「額外獎賞」。

2. 合資格簽賬之定義

由有關日期起，合資格客戶憑信用卡所作之任何保險繳費將定義為「其他簽賬」，合資格客戶可獲得無上限 0.4% WAKU COIN 基本獎賞而不享有額外獎賞。

Notice of Update on AEON CARD WAKUWAKU Reward Program

Thank you for your continued support for AEON Card! Please be informed that AEON CARD WAKUWAKU Reward Program will be updated. The below changes will start to apply to card transactions to be shown in the statements issued in June 2025 ("Relevant Date").

1. AEON CARD WAKUWAKU Reward Calculation

Starting from the Relevant Date, the ratios of WAKU COIN reward entitlement and the monthly cap of reward for Eligible Transactions made by AEON CARD WAKUWAKU will be changed as follows:

a)	Online Spending	0.4%	5.6%	6%
b)	Japan Overseas Spending	0.4%	2.6%	3%

In each monthly statement cycle, each Eligible Customer can enjoy unlimited Basic Reward and a maximum of \$200 WAKU COIN Extra Reward.

2. Definition of Eligible Transactions

Starting from the Relevant Date, any insurance payment made by Eligible Customer with AEON CARD WAKUWAKU will be categorized as "Other Spending", that Eligible Customer can enjoy unlimited Basic Reward of 0.4% but no Extra Reward.

3. The posting date covered in the Relevant Date

AEON will announce change in the Relevant Date, if any, as appropriate. Customers can visit www.aeon.com.hk for full version of the documents referred to below from the Relevant Date (or any deferred Relevant Date).

In conclusion, the Reward calculation of card transactions shown in the statements issued before the Relevant Date will follow the previous Reward Program terms and conditions.
